THE YEAR GONE BY

However, we thought we would bore you in advance with a brief recount of what has been happening at the DSOBS in 2004-2005. This does not mean that **Anoop (Billy) Bishnoi (112-J '75)** will spare you on 23rd October 2005 at the AGM. He will tell you all that we are telling you now and more – much, much, more – but atleast we would have prepared you in advance on what to expect.

Like most years, this year too, has sped by in a flurry of activities and a blur of Class and Regional get-togethers, Golf and Cricket fixtures and many DSOBS dinners and outings. Already, Founder's 2005 is round the corner – the 70th since School was ablished and five years short of the platinum mark – which we are sure will be an occasion which every Dosco, past and present, is looking forward to with great anticipation and pride.

'The Rosebowl' and the Rosebowl Concerts1

On October 17, 2004, when **Nitan Kapoor (151-J '66)** handed over the presidential torch to **Anoop Bishnoi (112-J '75)**, he also handed over to Anoop one of his unfinished projects – raising funds for the renovation and expansion of our very own amphitheatre – 'The Rosebowl'. Anoop, in carrying this torch forward, conceived of the idea of the Rosebowl Concerts as fundraisers for this project.

The early part of this year saw the **Doon School Choir and Orchestra Ensemble** perform in Delhi on April 2, 2005 and thereafter, in Dubai on April 4, 2005 by way of fundraiser performances for renovation and expansion of the Rosebowl. Executed by **Mr. Gursharan Singh (219-H '68)**, Director of Music

at the Doon School, the performances were organized by the DSOBS and its Dubai Chapter. The performances were runaway successes.

On the one hand, the Rosebowl Concerts enabled 54 enthusiastic and talented young Doscos to showcase their talents before larger audiences in India and abroad and on the other hand raised a much needed amount of Rs.24.09 lakhs for renovation of the Rosebowl.

From Tunwala to Tamil Nadu²

On December 26, 2004, a Tsunami of great magnitude and intensity ripped through the Indian Ocean, devastating our eastern coastal States of Andhra Pradesh, Tamil Nadu, Kerala and our Andaman & Nicobar group of islands, coastal Sri Lanka, parts of Thailand and Indonesia – leaving in its wake tens of thousands dead, injured, homeless, orphaned, widowed or scarred for life. The DSOBS rose to the occasion and reached out to those who had been ravaged by this disaster and its aftermath.

On this black Sunday and during the few days thereafter, many Executive Committee members were away for their winter break. Not one to be daunted, **Gautam Chadha (389-H '71)**, who had donned the mantle of heir apparent and Vice President, DSOBS on October 17, 2004, spearheaded the fund raising and thereafter, relief and rehabilitation work in the Tsunami hit coast of Tamil Nadu.

Thanks to the generosity of the Doon School Old Boys fraternity, their relatives, friends and friends of the Doon School, Rs.29.78 lakhs were collected by way of contributions of

which Rs.27.20 lakhs were utilized for relief and rehabilitation work. The balance amount of Rs.2.58 lakhs has been transferred to 'Navodya – a new dawn', a DSOBS account which will form the basis for relief work in case of any such future disaster. This Rs.27.20 lakhs has been used to provide over one million litres of clean drinking water, setting up of water treatment plants, water wells and distribution of bicycles, sports gear and truckloads of other relief material to those affected in coastal Tamil Nadu.

The DSOBS, in consonance with what we learnt in School, intends to continue to serve humanity – to give and not to count the cost – to labour and not to seek for any reward – except to see every tear wiped from every eye.

The Doon School alumni won the Doon vs. Mayo Alumni Gibson Goodwill Golf Tournament held on November 27, 2004 at the Classic Golf Resort.

March 5, 2005 saw the 4th DSOBS Inter-House Cricket Match³ held at the Central Secretariat Grounds at New Delhi with Hyderabad House lifting the trophy in a nail-biting final against runners-up, Tata House. Last year's champs, Kashmir House, fell early to Tata House and ended up third.

Recently, we had the 8th Edition of the DSOBS Inter-House Golf Tournament on September 17, 2005 at the Classic Golf Resorts, Gurgaon. Again, Hyderabad House emerged the Champs. Do we see some conspiracy here??

Apart from these large scale fixtures, we have had smaller sports fixtures at the Class and Regional levels with the Class of 1974's, 2nd Inter-House Golf Tournament held at Ranjit Nanda's [377-T '74) nine hole golf course next to the Golden Greens Golf Course in Gurgaon on February 26, 2005. Hyderabad House picked up the trophy (yet again) beating last year's champions Tata House. As this issue will indicate, we have also had the Golfingly Inclined Doon Alumni (GiDA) Golf Outing in the Washington DC area on August 6, 2005 across the Atlantic in the US of A⁴ while the United Kingdom saw the 11th Bawa Vikram Singh Memorial Golf Tournament held at the Hatfield Golf Course on Sunday the 26th of June, 2005⁵.

The future of sports in the DSOBS Diary seems bright with Gurmeet Singh (883-T '82) planning an old boys, inter-house soccer match closer to Founder's on October 15 & 16, 2005 at New Delhi. This will be the first ever Inter-House floodlit soccer tournament. We are told that many young ex-Doscos from all over the country and abroad are coming in to participate.

The fourth Doon v/s Mayo Alumni Gibson Goodwill Gold Tournament will be held on December 10, 2005. The Sports Sub-Committee will update you with details as we get closer to the event. All in all, a scintillatingly sporting year.

Get together make some bread

The year was also dotted with outings and get-togethers. February 2005 saw the Southern Chapter of the DSOBS spend a weekend with families at Ooti⁶ while April 2005 saw the annual Agra jamboree⁷. Delhi and other regions had many get-togethers big and small – some after the cricket matches and golf tournaments and some de-hors such sporting events.

DSOBS get-togethers have been held in the East and West coasts of the US of A, in the U.K., Australia and Dubai. Several batches — most notably those of 1969, 1974, 1976, 1979 and of-course the jubilee batches have been having bashes in diverse places from Corbett to Delhi and Kolkata. Too many to mention, but by all accounts, ex-Doscos all over the world are really rocking.

An interesting event which has now become a formal, institutionalized and regular feature (introduced by Anoop) has been a meeting followed by **dinner of all Class and Regional Reps** (on the very evening when the Executive Committee meets) with the members of the Executive Committee. These meetings and dinners have helped the Executive Committee Members, Class Reps and Regional Reps interact, exchange information and offer suggestions to build a better and more closely knit alumni.

Miscellaneous

We have tried to make both the **DSOBS website** and the **Rosebowl** more uptodate and spiffier in an attempt to turn them into better communication tools for the fraternity. We have already published four issues of the Rosebowl (including this issue) this year while our website is constantly updated with the latest information.

The Bursary Sub-Committee disbursed a total of Rs.3.10 lakhs by way of bursaries most of which went to sons of nine old boys of the Doon School (Rs.2.70 lakhs) and some to the John Martyn Memorial Trust School-Salagaon Primary School (Rs.40,000/-). Anoop himself has personally committed to contribute Rs.1,10,000/- towards the bursary funds this year.

The Dosco Record 2006 is under preparation. Those of you who have not filled in the form sent as a flier with the July 2005 issue of the Rose Bowl must do so now and send it to the DSOBS Secretariat either in hard print or electronically.

Work on the ambitious "History of the Doon School" is underway. We attempted baiting Arjun Mahey [477-J '74] spearhead these efforts but litres of lager notwithstanding Arjun remains non-committal. We are hoping that another few gallons will do the trick. We also intend to rope in other eminent old boys, skilled in the written word, to help us with this project which would see the History of the Doon School being ready for release in the platinum jubilee year – 2010. The DSOBS would also welcome volunteers for this purpose (see last page of this issue).

The Memorabilia Sub-committee has also introduced **new memorabilia** including designer collared T shirts, boxer shorts, overnight bags, etc.

While the Admissions Advisory Sub-committee has been supporting and guiding prospective old boy parents in getting their children/wards admission to the Doon School, the Sub-committee on Post School Education Assistance and Job Placement has also ensured that old boys not able to meet expenses of higher education are supported in their moments of need. Ex-Doscos have also been placed suitably with other ex-Doscos who have the capacity and need to absorb deserving candidates in their workforce. 'The Post School Education Assistance' is a first – for which a corpus is being built up to disburse funds, strictly on need basis, to deserving ex-Doscos to pursue further studies.

What lies ahead

Another project on which the DSOBS is currently working is a fund raising endeavour for **re-building** the **Art School** for which it has planned the **DSOBS Art Show & Auction Ensemble**.

As you would have noted in the earlier issues of the Rosebowl⁸, we have requested eminent artists to work on paintings – to be combined with School paintings – which (combinations or ensembles) will be auctioned as a part of this fund raising effort.

Ultimately, it must be remembered that the objects of the Society as spelt out in its Memorandum of Association include the following:-

"3. OBJECTS

- (a) To further camaradere between the Old Boys of the School and with the Doon School itself;
- To assist each other in furthering the aims and objects of the institution;
- (c) To encourage the Old Boys to take an active and abiding interest in the work and success of the Doon School in keeping with the ideals of the School;
- (d) To promote friendly relations between the Old Boys, the present boys and the Staff of the School;
- (e) To endeavour to live up to the motto of the Doon School i.e. 'Knowledge is light';10
- (f) To establish a bond of union among old boys and between them and The Doon School, to foster a

- spirit of comradeship, to promote co-operation and to extend mutual help to the old boys of the school;
- (g) To organise and develop activities in areas of cultural, social, economic and educational fields, to keep alive the spirit of devotion to the pursuit of excellence in all the above areas and more particularly towards education and human resource development;
- (h) To help, encourage and assist the spread of education and to render assistance, award scholarships/bursaries to deserving students and for this purpose to take all steps as may be necessary;
- To help in finding avenues of employment or occupation and in acquiring facilities for technical, vocational and professional training to students in India;
- (k) To create, associate, or co-operate with any other Society or Association having the same or similar objects in such manner and to such extent as may be desirable and possible;
- (I) To sponsor, promote and organise schemes for the protection of ecology and environment as well as total life support systems for nature and its conservation as well as for the promotion of arts and crafts, sports and activities connected therewith.
- (m) To organise workshops, seminars through members of the Society in different parts of the country for educating and upgrading awareness of the general public to issues related to nature and national resources in order to highlight the dangers of environmental degradation and pollution. To promote public participation for preserving the national eco and life support systems of nature;
- (n) To promote, sponsor, encourage schemes and projects and focus public attention on issues related to the preservation of our national heritage in all fields as well as to highlight the responsibility of the present generation in this regard and their accountability to the future generations;
- (o) To extend the experiment of The Doon School towards promoting national integration through the destruction of barriers of caste, creed, colour, race and regionalism by extending the same through the medium of the members of the Society on a larger national scale;
- (p) To provide leadership in promoting national integration by encouraging and supporting the spirit of adventure and discovery."

This Executive Committee has been doing its utmost to further the objects of our Society. However, we leave you, the General Body of the DSOBS to be the ultimate judge.

We look forward to meeting up with all of you at Founder's 2005 between October 21 and 23. We also take this opportunity to wish the Classes of 1945, 1955 and 1980 – a super Diamond, Golden and Silver Jubilee year, respectively.

DR. P.M. DAS, IPS

ADDITIONAL DIRECTOR GENERAL OF POLICE - MAY 22, 1953 TO SEPTEMBER 24, 2005 AN OBITUARY By K.K. Lahiri, 30-K, 1974, The Editor - Rosebowl



The Doon School Old Boys community was shocked and deeply saddened at the untimely demise of Dr. Parash Moni Das, 298-H '69, who died a mountaineer's death on Saturday, the 24th of September 2005 while leading a National Level Expedition to a high mountain in North Sikkim along the Chinese border. This five week expedition had commenced on September 7, 2005 but unfortunately, Dr. P.M. Das, leader of the expedition and an IPS Officer, perished alongwith five other expedition members in an avalanche in this treacherous terrain. Of the six who perished, three (including Dr. Das) belonged to the Punjab Police. Three other expedition members have survived.

Dr. Das hailed from Guwahati, Assam. Born on May 22, 1953 to Mrs. & Mr. L.C. Das of the Indian Forest Service and Conservator of Forests, he completed his ISC from the Doon School in 1969 and went on to Graduate and complete his Post-Graduation in 1973 and 1975 respectively from St. Stephen's

College, Delhi University, Delhi. Dr. Das did a brief teaching stint at Mayo College, Ajmer from 1975 and thereafter, taught at the Doon School, Dehra Dun from 1977 till he joined the Indian Police service in 1978.

Recently promoted as the Additional Director General of Police, Computerisation and Telecommunications, Punjab Police Headquarters, Chandigarh, Dr. Das, in the true Dosco spirit, lived for 'hills to climb' and 'hard work to do'. An avid mountaineer, Dr. Das had led many a mountaineering expedition to peaks such as Banderpunch, Hanuman Peak, Mamostang Kangri and Mount Everest. In September 2004, he led an Indian Team for training and mountaineering to the European Alps and made ascents of as many as seven peaks. Dr. Das himself reached the summits of Riffelhorn, Breithorn, Dufourspitz, Allalin (Sass Fe), Moonch ascent by the (different) South-Western Ridge and descent by the Eastern Ridge and Mont Blanc – the highest peak in urope.

Married to **Chandana** on January 30, 1982, they have a son, **Shyamantak Das, 309-J '04**, who is currently pursuing his Graduation studies at Muskingham College, Ohio, USA and a daughter, **Teestha Das,** who is currently in Class XI in Welham Girls School, Dehra Dun.

Ultimately, the very mountains which he loved so dearly claimed him as their own. A true mountaineer till the very end, Dr. Das will always be remembered by the entire ex-Dosco community as someone who epitomized the Dosco's limitless zeal to 'climb every mountain'.

The Doon School Old Boys community extends its heartfelt condolences to Chandana, Teeshtha, Shyamantak and his entire family. May Parash Moni's soul rest in eternal peace.

The gang, alongwith spouses and children, was large enough to occupy almost half of an entire railway carriage. It brought back fond memories of the Bombay party. Even though we were far more varied in age, the bonhomie, laughter, and comfortable companionship was infectious. Just two days in Ooty had brought the group together in friendship and good cheer.

We must have been a sight with enough luggage between us to pile up on a large flatbed cart. The cart rattled loudly as we trundled down the platform to our bogie. Siddharth Lulla and I were trying to hold the bags and stop them from falling off — while also trying to avoid getting our feet run over by the metal wheels.

So engrossed were we as we settled down for the evening, that we didn't even notice that the train had slowly pulled out of the station and was heading for the first stop – Coimbatore. We were



DR. H.D. BHATT 'SHAILESH'



Once in a while we need to jog our memories and remind ourselves of the great teachers we had while at School. Many of them were and are prolific writers and academicians. Dr. H.D. Bhatt 'Shailesh' was and is one of them. A former Housemaster (Kashmir-'A') and Head of the Indian Languages Department of the Doon School, Dehra Dun, he is presently settled as a freelance-writer in Shail Shikhar, Mussoorie. Dr. Bhatt's wife, Mrs. Bhatt was Dame of Kashmir House after Mrs. Heinz retired in 1973. Parents to Himani (409-K '73) and Himanshu, (518-K '81) and grandparents to Katyayan Shivpuri (156-K '2003) – Mrs. and Dr. Bhatt were parents to us all. Many of us envied those in Kashmir-'A' who were so fortunate to have Dr. Bhatt as their Housemaster.

Dr. H.D. Bhatt 'Shailesh' is one of the foremost modern writers and a trend-setter in Indian Literature. He pioneered fiction-writing woven around mountaineering and life in the hills. To his credit go 41 published books and about 450 short stories, features, articles, one-act plays, travelogues and reminiscences.

Many features and short stories, written by him, have been broadcast over the AIR, the BBC and the TV. He is also a regular contributor to Hindi and English journals and magazines. Many of his short stories have been translated into different languages. He has produced and directed a number of plays and acted as President and Secretary of many a literary and cultural society.

He was honoured by the President of India for his contribution in the field of Child Education and by the Delhi Sanskrit Academy Uttarakhand Srodh Sansthan, Uttarakhand Kala Manch, Hindi Sahitya Sammelan, Rashtrabhasha Hindi Parishad, ONGC, Himalay Paryavarn Society, the Kalidas Samaroh Samiti etc. He was twice awarded cash prizes by the U.P. Government for his books on mountaineering. He was also awarded a gold medal for his one-act plays.

We have requested Dr. Bhatt to keep his books available on display in School during Founder's 2005 to enable his former students and other ex-Doscos to purchase or order them. A list of his books are given below

FROM TUNWALA TO TAMIL NADU

I have now made two trips down to Sirkazhi and Mayiladuthurai. Sirkazhi is just south of Chidambaram, where the famous temple dedicated to Bharat Natyam is, and Mayiladuthurai or Mayavaram is further south. Both these towns fall within the Cauvery delta, a region that is criss-crossed by numerous channels and much of it is low lying land. This is why it was pretty badly hit by the Tsunami of December 2004.

The first trip was together with Alok Bhargava (Chennai Rep. of the DSOBS, 196-J '74) in May, when we attended a meeting held to review the relief and rehabilitation efforts in Mani Shankar Aiyar's constituency. At this time we met the Minister and presented a (token) sports kit and discussed the logistics to get the bicycles and sports kits donated by the DSOBS to his people in the constituency. He was very pleased to see us and thanked the DSOBS for the efforts made by the Dosco fraternity. He insisted that one or more of us should come there again in June and tour the constituency.

It so happened that I was able to be there



in July when I accompanied Mani Shankar Aiyar to the village of Thirumulaivassal on the coast, east of Sirkazhi. The ruins of many houses greeted us along the sandy shore but so too did a large crowd of villagers and children. I was certainly not prepared to participate in a crowded meeting in the hall of the temple, receive a shawl from the Panchayat leaders and have a microphone thrust into my hands and asked to say a few words on behalf of the Doon School Old Boys. Somehow, having managed this in my broken Tamil, I was relieved to hand the mike over to Mani Shankar Aiyar who proceeded extol the virtues of the Doon School to the gathered villagers and they applauded the efforts made by you all to get these 500 bicycles and 300 odd sports kits to them. It became obvious that the gifts were very welcome and useful - though as the Minister said, they could have easily distributed 20,000 bicycles and even that may not have been enough! The bicycles were given to children who had lost both or one parent in the Tsunami and the sports kits were handed over to the members

of the Youth Clubs that are there in every village.

It takes a lot of time to go through these meetings and speeches and Mani Shankar Aiyar certainly has a very strong and genuine bond with members of his constituency. We were able to only cover two villages on this part of the coast as access is not always easy. We stopped

for lunch that had been organized at a farm nearby and I left afterwards as I had a 3 hour drive home. I have received a list of 127 children who have received bicycles as of now and as and when Mani Shankar Aiyar comes to visit his constituency the distribution goes on.

I think you should all be pleased with the results of all the efforts made, first to raise the funds for the relief, then to get the materials over to Tamil Nadu and now, the distribution to the right people. I feel privileged to have been a of the part chain.








"Radha Krishna Mandir, dating 17th Century A.D. by Vinay Deshpande, (101-J '83)

- III. The Minutes of the 64th Annual General Meeting had been circulated to all Members present at the commencement of the meeting. The following points arose from the said minutes for discussion during the meeting.
 - (a). Mr Saroj K Mehera (Ex 122-K '44) informed the members present that Mr. Shahenshah Hussein (Ex-246-K) and Mr. Rajendra Vikram Singh (Ex- 056-H) were from the Classes of 1942 and 1943 respectively, and not from the Classes of 1944 and 1945, as mentioned in the Minutes of the 64th AGM. He requested that the minutes be corrected accordingly.
 - (b). Mr Jaspreet Singh (Ex 285-T '76) raised the subject of selection of Vice President of the DSOBS which has been a contentious topic for several years.

It was decided that once the nominations for the post of Vice President were received by the President, these would be forwarded to the Executive Committee of the Society where the Past Presidents and the Regional Representatives are invitees. The Executive Committee would meet to deliberate on the names received and from among them, select one name for approval at the Annual General Meeting.

If even after this, the matter was not resolved, the names would be put up at the Annual General Meeting for the House to make a selection.

With the above clarifications, the Minutes of the 64th AGM was proposed for approval and confirmation by Mr Baljit Singh Malik (Ex 73-K '55), seconded by Brig B N Singh (Ex 76-T '54) and confirmed and approved by the House.

IV. Annual Report by the President : -

The year Oct 2003 to Sept 2004 had been an eventful and busy year. The Executive Committee of the DSOBS, apart from meeting 4 times in the past 12 months, decided on a major issue i.e. purchase of Permanent Secretariat for DSOBS. The Society acquired the Office premises in Bhikaji Cama Bhawan, Bhikaji Cama Place, New Delhi. I would like to summarize the activities of the society, including the excellent work done by various sub-committees each headed by a member of the Executive Committee. Many members from the fraternity, outside the Executive Committee, have also contributed from time to time, their valuable time and efforts and I wish to record my thanks to all.

Before I report on the various sub-committees I wish to briefly inform you some important milestones achieved by the society:

 DSOBS Permanent Secretariat: The thought of having an independent office for DSOBS has been there for a very long time. I have the pleasure of informing you that we could achieve this in the year 2004. I am happy to inform you that the Society could collect a total of Rs. 95.15 lakhs. The new office is an excellent 1450 sq. ft property situated in Bhikaji Cama Bhawan, Bhikaji Cama Place, New Delhi. The property enjoys a breath-taking view of Delhi and is centrally air-conditioned. I wish to record my sincere gratitude on behalf of the entire DOSCO Fraternity to these generous sponsors with whose help, this dream has become a reality. I also thank everyone for their assistance in acquiring this office.

I along with other members of the Society, wish to extend our special gratitude to Mr.Arun Bharatram (Ex 36-K '58) for his unstinted support to the Society for over 20 years, without which, our Sub-Secretariat in Delhi, could not have functioned.

- Our congratulations to the Class of 1979 who celebrated their Silver Jubilee this year. I take pleasure in informing you that they have collected approx. Rs. 35 lakhs for this occasion. Apart from the jubilee, which they celebrated on a grand scale, they propose to donate the balance amount to the School for the various projects. I thank all Old Boys of the Class of 1979 for their efforts and generous contributions. Another Rs. 5 Lacs has been promised yesterday.
- DSOBS contributed Rs. 35,000/- for Homes for Happiness Project of the Leprosy Mission, Dehra Dun by releasing advertisements in the Souvenir received from the members of our fraternity. I express my thanks for this.
- 4. During last year, the Society received an appeal for **financial help for Mr H D Manocha** who served the School for near, 40 years before retiring as Admission Officer. The Society donated Rs. 56,000/- towards this; Rs.36,000/- being contributions from the Old Boys and Rs. 20,000/- being the Society's contribution. I do hope Old Boys would be forthcoming towards this noble cause in future also.
- 5. The Society, continuing the "international flair", held get-togethers in various parts of the globe including Singapore, U.K., UAE, Nepal, Philippines and apart from the domestic ones in many cities in India. This interaction of Old Boys has given an opportunity for a much larger body of the fraternity to be actively involved in the society's affairs and progress. I am sure that members of our fraternity have been following these events through the website and the Rose Bowl.

I would now like to briefly report on the various sub-committees and their activities over the past 12 months:

- BURSARY This sub-committee is chaired by Mr.Chudamani Ratnam and assisted by Mr.Ravibir Singh. This year DSOBS awarded bursaries/scholarships to 13 Old Boy's children amounting to Rs. 3,58,000/- including 10 bursaries amounting to Rs.30,000/- to The John Martyn Memorial Trust, which runs Salangaon Primary School. The total sum disbursed was Rs.3,88,000/- I would urge all Old Boys to donate as much as possible towards the DSOBS Scholarship Fund.
- 2. CREDIT CARDS This sub-committee is chaired by Mr. Anoop Bishnoi and actively assisted by Mr. Ravibir Singh. Presently the society has successful Affinity Card programmes with Citi Bank for the Diners Club Card and Standard Chartered Bank for a Visa/Master Card. At present we have a total of 707 cardholders, which is less than 20% of the Dosco OB's community within India. As you may be aware we have a voluntary contribution scheme whereby an Affinity cardholder contributes Rs.250/- per month to the society. Of the total 592 Standard Charterd Bank cards issued ONLY 40 have signed up for this monthly contribution. I would request more Old Boys to come forward and apply for the affinity cards and sign up for the monthly Rs.250/- contribution. This will help support your society as well as the School.
- COMMUNICATIONS DSOBS Website and Rose Bowl Sub-Committees have been combined to form the Communication Sub-Committee headed by the Vice President, Mr. Anoop Bishnoi. Other members are M/s. Ajay Swarup, Ajay Mehta, Ravibir Singh, Sharad Sharma and Ratan Kapoor.

DSOBS Website: The Society has arranged a contract with an old Boy, Mr. Hemant Sharma (Ex 459 – JA '81) of Trisoft for the Website. The DSOBS website is undoubtedly the most powerful medium of communication for all members of the fraternity. It is therefore the endeavour of the society to keep improving this facility so that our widely spread fraternity can be in touch with activities of the society and be able to share information on a daily basis. The website is being constantly redesigned to meet current needs but a lot more work needs to be done. The Doon School directory has been integrated with the website and an online search facility is available using either the name, roll number, batch, city, etc. The Rose Bowl is also added to the site almost simultaneously when the publication is mailed to members. To increase revenue for the Society we could advertise on our website. All members are requested to please make a note of this and give advertisements for our website.

ROSE BOWL – The excellent work done by Mr. Ratan Kapoor (Ex 124-JA '84) and the sub-committee is reflected in the quality and content of this publication. This year we have published 3 issues with the fourth due towards the end of this year. Our sincere thanks to Mr. Gautam Thapar (Ex 200-H '79) for his generous contribution in donating high quality paper for publication of Rose Bowl. Each issue of the Rosebowl is financed by means of strip ads and I would urge members of our fraternity to come forward with ads and more importantly send in articles/photographs to the editor. I wish to thank those who have contributed towards advertisements in the past year and others who may come forward. As you all may already know a copy of the Rose Bowl is mailed free of cost to all members of the society whose addresses are current and updated. I would like to thank Manu Vohra (Ex 289-JB '85) for assisting the Rose Bowl Sub-committee. He has done an excellent job in coordination and in getting the issues printed.

- 4. JOB PLACEMENT This sub-committee is handled by the Executive Secretary DSOBS. The society is in constant touch with the Old Boys requiring placements. We have about 40 applications, which have been forwarded to prospective employers and Placement Agencies. In addition we have also published details on DSOBS Website. As Old Boys who get placed, do not inform the Society, there is lack of such information with the Society. I request Old Boys in the corporate sector to help out in getting placements for needy persons. Further, when Old Boys get placed suitably or relocate, the Society should be informed.
- 5. MEMORABILIA This sub-committee is chaired by Mr. Jayant Sahai and assisted by Mr. Ajay Mehta. Dosco memorabilia is available from Mr. Ajay Mehta's office in Safdarjung, in the General Store at School and on-line through dsobs.org. Many new items have been introduced. These have been published through website and Rose Bowl. I would request Old Boys to buy memorabilia regularly and wherever possible use these as corporate or personal gifts. With on-line sales being made possible we expect to increase the sales of memorabilia considerably.
- 6. **SPORTING ACTIVITIES** This sub-committee is chaired by Mr. Gautam Chadha and assisted by Mr. Gurmeet Singh. As in the previous years, this year too the sporting events were excellent which included the DSOBS Annual Golf Tournament at the Golden Greens Golf Course in Gurgaon on 9th Oct. 2004. There were a total of 136 contestants, who played at this challenging course. Congratulations to Jaipur House on winning the trophy. Hyderabad House was runners up. The tournament was followed by a well-attended dinner at the Maurya Sheraton on Oct 10, 2004. On behalf of the society, I wish to record my thanks to the sponsors Cholamandalam Investments, EID Parry Murugappa Group, Star India, Yes Bank, Voltas, Tiger Sports Management, etc. for this event.

In Dec 2003, the 2nd Gibson Goodwill Golf Tournament between the Doon School and Mayo College alumni took place at Jaypee Greens Golf & Country Club, Greater NOIDA, U.P., which ended in a tie.

In Feb this year the Inter-house Cricket Tournament was held at the Central Secretariat Grounds which was followed by a dinner at Thai-Wok, Delhi. Kashmir House won the tournament and Hyderabad House was declared as Runners up. Many DOSCOs attended this both from Delhi and places outside Delhi. Another sports fixture was the Patiala Golf in March 2004 which was also well attended.

- To sum up, the year has been an active one on the sports front and this Sub-Committee has excelled in its efforts. Our appreciation to both Gautam and Gurmeet for putting up such great events.
- 7. ADMISSION ADVISORY This sub-committee is chaired by the Vice President, Mr. Anoop Bishnoi and assisted by M/s. Chudamani Ratman, Sharad Sharma and Gurmeet Singh. This year, out of 37 boys who appeared for admission, 25 were selected. Many Old Boys have contacted the Sub-Committee for help and guidance with regard to admissions. I would like to mention here that the sub-committee cannot assure admissions, but can only help in giving out information, providing past test papers, etc. The sub-committee cannot in any manner whatsoever, interfere with the Board/School on admissions. The responsibility rests entirely on the parents to prepare their wards well, so that there are fewer disappointments.
- 8. **The DOSCO Register/Record** This sub-committee is chaired by Mr. Lalit Bhadwar and assisted by M/s. Ajay Swarup and Ratan Kapoor. The last DOSCO Register was published in 2002 and the Record in 1996. The next issue is due in 2006 and the work is under process. If there are any suggestions from the house please contact Mr. Lalit Bhadwar. Any member wishing to sponsor the above would be most welcome.

I would also like to thank the past Presidents, the Vice President, Mr. Anoop Bishnoi and the Hony. Secretary, Mr. Rajbir Singh for their assistance to me in fulfilling my obligations and duties.

- B) With regard to Admissions of Old Boys' wards, Mr. Ravibir Singh (Ex 19-K '83) suggested that any vacancy, which may arise during the mid term, would be given to Old Boys' children in future. This suggestion was welcomed by the House.
- C) Mr. Nalin Khanna (Ex 563-H'80) wanted to know the reason why a certain member had not been selected for Membership of the Executive Committee. According to him, this member had done lot of work for the Society in the past. The President, Mr. Kapoor informed him that the concerned candidate was also the Delhi Regional Representative and in his said capacity was always invited to attend all EC Meetings and could continue to contribute further in this capacity too.
- D) Mr. Satinder Puri (Ex 49-K '52) referred to Mr. Rajbir Singh's letter to the President regarding change in the Society Conventions. He wanted Mr. Anoop Bishnoi, the President to read the letter, discuss it and reply suitably to Mr. Rajbir Singh. - IX. The President hoped to establish a Corpus for this and he requested everyone to support and render help for this cause.
- c) He appreciated the efforts of Mr. Nitan Kapoor for his unstinted and excellent work done in the past many years. He stated that he had the highest respect for Mr. Kapoor and would always have the fraternity's and school's interests at heart.
- d) The President wanted Members to focus on the fraternity and suggest ways and means to improve this.
- e) The President stated that there was plan for a Dosco Summit next year where IPSS, BOG and EC Members would meet and discuss all important issues.
- f) Finally, he expressed his gratitude to all Members and assured them that he would not let them down.

Mr. Saroj K Mehera (Ex 122-K '44) proposed a vote of thanks to the outgoing President who had served the Society so admirably during his tenure. He also thanked all outgoing Members for their work and welcomed the incoming President and the New Committee members.

P. M. DAS, MY FRIEND¹³

The Last Post has sounded. A brilliant career comes to an end. Dr. Paras Moni Das, Additional Director General of Police in Punjab, is no more.

It was exactly 40 years ago that a small, timid boy in 'D' Form wrote an article for this Weekly titled, 'My Friend Bharat'. How was I to know then that I would attend his funeral in Patiala on 28 September 2005 accompanied by some of our classmates and roommates. With all pomp and ceremony, PM was consigned to the pyre amidst a devastated family and grieving friends and colleagues.

"Posh Dosh", as he was sometimes called by us, was a fine runner and excelled in track events. He played for Hyderabad House in the team sports, but did much better in individual activities like boxing and cross-country. Always an achiever, he went on to win the Markers Cup for Maths and got a high 1st grade in the Senior Cambridge examinations.

A roommate of mine throughout our schooling, PM was a brave boy and would stand up to the toughest kids (even me) when required. A kindly soul, he was ready to help where he could (Maths, in my case). An individualist by nature, he formed his own opinions about everything and everybody, sometimes against popular beliefs. A hero, both in his professional and personal life.

PM was a Master in School for a short stint and then joined the Indian Police Service in the Punjab cadre. His hobby and passion was mountain climbing. Living day-to-day through these dangerous activities, PM cheated death on numerous occasions. He was shot in the chest as a policeman and escaped from a mountaineering accident. Death finally overtook him and his colleagues last month when a massive avalanche buried them on a mountain slope in Sikkim. He was a good friend from start to finish.

JENNIFER KENDALL KAPOOR – A SCHOOLBOY'S FANTASY.

It all started with a page out of "Serving Crazy With Curry," a recent novel by Amulya Malladi, one of the many new Indian authors who write about the immigrant experience in America. Very briefly, it is a story of a family in crisis with complex relationships between mothers, daughters, husbands, fathers, and sisters. A distressed daughter finds an emotional outlet through cooking, which gets spicier when she is angry. It is a dark comedy, delightful and entertaining. In the book, one of the quests at a party at an Indian Californian home happens to be a hasbeen Bollywood actress. Of course, she becomes the central focus of the party and, enjoying the limelight, is encouraged to talk about her onscreen experiences. A proficient namedropper, she casually mentions acting opposite Shashi Kapoor. She holds her audience keenly attentive and totally captivated when she talks about Shashi's personal life like she was his closest and dearest friend and discloses how devastated Shashi was when his wife Jennifer passed away.

Jennifer? Jennifer, I thought. Heck, I knew Jennifer. I knew Jennifer when I was about 15 and in Doon School. My gosh, that one sentence in the book brought back so many memories.

Jennifer Kendall was the daughter of the Kendalls of Shakespeareana fame. They and their troupe traveled the world over, performing Shakespeare, George Bernard Shaw, etc. in which Jennifer usually played the female lead. About once a year, they visited the School for about a week and performed in the Rose Bowl. Sometimes schoolboys

performed with them though mostly in secondary roles and as extras, except for Deepak Lal (H-319, SC '55, ISc '57). Deepak (I hope he will forgive me when he reads this) was a celebrated actor of his time, and he looked and acted especially well when he performed female leads – such as Ophelia, or was it Juliet? But I digress from Jennifer.

I, too, sometimes got a chance to act with the Kendall troupe or if not, I tried to volunteer for stagehand or just a gofer so I could be close to Jennifer and look at her. Jennifer, at the time, was, I would say, about 22 years old. She was a blonde English beauty who was in the dreams of all who I knew. At 15 or 16, all those I really knew consisted of other 15 and 16 year olds whose hormones were forever in a state of high ecstasy (those are Anil Anand's (T-39, SC '55) words in 1955, so I want to give him due credit).

Jennifer was tall. Jennifer was slim. She was always so charming with us boys, flirting sometimes with the fortunate ones. She lit our fire. She gave us an unusual but somehow indescribably delicious ache in the solar plexus. I think she had this effect on all, because so many just hung around with open mouths. I know for sure she had that effect on me. My best friend, Madhukar Saran (T-97, SC '55), could vouch for that.

A few years later I heard that she had married handsome actor Shashi Kapoor of the Bollywood Kapoors, a dynasty that reigns supreme even now, some fifty years and two generations later. But life intervened and I never thought of Jennifer again, until I read

this novel.

I was curious. What happened to Jennifer? She died? When? She wasn't that old. What was her life like? She had given so many of us so much pleasure at our tender ages and left us with so many unfulfilled, yet pleasurable, dreams and fantasies. I wanted to find out.

So, I did what one does these days. I Googled "Shashi Kapoor" and I found hits galore about the Kapoors. I studied the family pictures, a couple with Jennifer with her children.

Children?! Well, why shouldn't she have had children. After all I have grown older and I have children. Just because I hadn't thought about Jennifer, didn't mean she was standing still as the world moved on and I got older. But this wasn't enough. I wanted more.

On a hunch, I Googled "Jennifer Kendall" and there it was. An entire page on Jennifer Kapoor. Perhaps it was written by Shashi. Perhaps by someone close to them. It told the poignant story of how they met and fell in love and their trials and tribulations as they tried to get their families' to accept their union. It talked about their love for one another and their twenty-six year marriage, three children and tragically, cancer claimed her in 1984.

Reading "Serving Crazy with Curry" and Googling Jennifer brought back so memories of school and friends, teachers and the campus. Although there are so many I will never see again, I hope to refresh the memories when I visit the school again and walk over to the Rose Bowl.

"Sir,

read with much enjoyment and some nostalgia Manucha's reminiscences. Perhaps I might throw some light on the Bhanwar Singh incident and add some snippets, if your space permits. Bhanwar Singh, and some others, attended the Assembly on April 13, the anniversary of the horrendous massacre at Jallianwala Bagh, with black armbands. Foot said at the end of Assembly that he noticed an addition to the school uniform and asked that it be removed. Dinesh Singh told me many years later that he and some others had met Foot later in the day. Evidently, they could not dissuade Foot from expelling Bhanwar. I did not know about what happened at the playing field but I doubt very much that Foot, being the sort of man he was, would have bowed to the remonstrances of the boys. I think it more likely that he obtained an undertaking from Bhanwar's parents, and had always intended to, that Bhanwar would not indulge in politics again while in school. This might explain why he came back a different person: perhaps he felt that he had been let down by his parents.

But Foot was by no means a dyed-in-the-wool colonial Britisher. He had written to a national newspaper during the war objecting
